HEALTH SCIENCES FESTIVAL INSTITUTIONAL STAKEHOLDERS COOPERATION PROTOCOL

Sağlıkfest aims to introduce innovative health models with model design competitions to address the current and future problems of health, as the most fundamental right of humanity. Sağlıkfest is a national health sciences festival organized with the participation of many stakeholders in Türkiye with its mission including innovative approaches. In this context, Sağlıkfest represents an integration of eight model design competitions under high school, associate degree, undergraduate, graduate and open categories, along with professional, cultural, artistic, educational and sportive field activities.

The purpose of this protocol is to explain the content of the steps to be taken and the contributions to be made by the **institutional stakeholders** of the festival, both in the competition phase of Sağlıkfest and in the workshops for the field.

The Rectorate of Karabük University and its institutional integrity is the coordinator and project executor of the Sağlıkfest organization, in which it has shaped the context of thought, practice and implementation. This institutional integrity owns the organizational ownership and property. The steps to be taken by the institutional supporters, stakeholders and sponsors of the festival are determined by Karabük University Rectorate and its institutional integrity, which is the representative of organizational ownership and property. The actors referred to as institutional stakeholders of Sağlıkfest, both in the competition phase and in the workshops for the field, are expected to be able to provide support to the festival in **at least two or three** of the following categories: implementation support, field support, communication and

promotion support, financial and financing support. In order to become an institutional stakeholder, it is necessary to provide support in 2 or 3 of the 4 types of support.

- **a. Implementation Support;** The expectation from the implementation support is that the institutional supporting actor supports the festival in a way to use their logistic and technical infrastructure facilities in the field activities of the festival.
- **b. Field Support;** The expectation from field support is that the institutional supporting actor supports the festival in a way to use their human resources and physical field facilities in the field activities of the festival.
- **c.** Communication and Publicity Support; The expectation from communication and publicity support is that the institutional supporting actor supports the festival by using their publicity and propaganda opportunities in order to make the festival reach a wide audience. Communication and publicity support is an important basis for promoting this festival, which will improve the social thinking skills of The Youth of Türkiye Century, as widely as possible and attracting visitors to the area. Communication and publicity support can include the promotion of the festival in physical and social media advertising applications, as well as short films that include the invitation message of corporate faces to the festival.
- **d. Financial and Financing Support;** This is the support of the institutional supporting actor to the festival in a way to use its pecuniary monetary financial resources in the competition and field works of the festival.

The actors referred as the institutional stakeholders of the festival are expected to be able to provide support to the festival **in two or three of these four support headings**. Within the scope of this protocol, the addressee has become a party to the protocol as a **Institutional Stakeholder of Sağlıkfest** by accepting and undertaking above matters to provide support.

OTHER PROVISIONS


By virtue of this protocol, the parties will be responsible for their own contributions to joint activities.

DURATION AND TERMINATION

This protocol will be valid within the scope of Sağlıkfest organizations after it is signed by the legal representatives of the parties. The protocol may be terminated unilaterally upon the request of one of the parties. In case of unilateral termination of the protocol, no legal and financial liability is imposed on the parties. In this case, the ongoing work will be completed.

ENFORCEMENT AND EXECUTION

This protocol and any additional protocols shall enter into force when signed by the legal representatives of both parties. The protocol is executed by Prof. Dr. Fatíń KIRIŞIK, Rector of Karabük University and Prof. Dr.Tursunbaev Zhanbolot Zhanyshovich, Rector of Osh Technological University.

AGREEMENT OF UNDERSTANDING FRAMEWORK FOR ACADEMIC COLLABORATION

Between OSH TECHNOLOGICAL UNIVERSITY NAMED AFTER M.M. ADYSHEV KYRGYZ REPUBLIC

Represented by **Prof. Dr. Tursunbaev Zhanbolot ZHANYSHOVICH** Osh Technological University

&

KARABUK UNIVERSITY TÜRKİYE

Represented by **Prof. Dr. Fatih KIRIŞIK** Karabuk University

(Hereinafter referred to collectively as the "Parties" or individually as the "Party")

Whereas

The Parties have decided to enter into this Framework of Academic Collaboration (hereinafter referred to as "Agreement") in order to promote, facilitate and consolidate international cooperation in education and research, based on the principles of reciprocity and mutual benefit.

Decide as follows: Article 1. Areas of Corporation

The areas of cooperation shall include, subject to mutual consent, any activity or program at either institution as considered feasible and desirable on either side in order to foster and develop the cooperative academic relationship between the two parties.

The implementation of research and study programs determined in conformity with Article 1 may be carried out through the joint realization of research projects and teaching programs at the location of both Parties, according to the modalities specified in Article 4 of this Agreement.

More specifically, these are the modes of cooperation that may be used in a separate appendix to which the parties agree to, included the following:

- Exchange of scholars
- Joint research projects
- Joint teaching and/or supervision of students
- Joint participation in workshops and/or conference days
- Student mobility and prospective exchange of students (as may be mutually agreed upon)
- Participation of students in Study Abroad programs hosted by each institution.

Article 3. Liaison

Where needed, the Parties will appoint a faculty member as coordinator of the activities entailed in this Agreement who will also be responsible for facilitating and maintaining communication with the other Party for that purpose.

Article 4. Specific Cooperation Agreements

Nothing in this Agreement shall be construed as creating any legal or financial relationship or commitment between the two Parties.

The terms of collaboration and the necessary funding for each program and activity shall be mutually negotiated, discussed and agreed upon in writing by both Parties in separate specific cooperation agreements prior to the initiation of any particular program or activity. Each institution will designate where needed, a lead coordinator for the activities or programs of potential cooperation that may form the basis for specific cooperation agreements to be executed between the parties.

Besides implementation modalities specifying academic, organizational, technical and financial aspects, specific cooperation agreements shall contain terms relating to intellectual property rights and procedures for publication etc.

Article 5. Principles

All participants will be treated in the same non-discriminatory manner in carrying out the provisions of the Agreement, subject to the provisions of the policies and requirements of each of the institutions.

Article 6. Terms of Cooperation

6.1 Duration

This Agreement shall commence on the later of the two dates of signature of the parties, this being the date when both parties have duly accepted the conditions laid down in this Agreement. The Agreement shall be in force for five (5) years and may be renewed or extended by mutual written consent of the authorized officials of the parties to it.

6.2 Amendments

Any amendment and/or modification of the Agreement will require written approval of both Parties and shall be appended hereto.

6.3 *Termination for convenience*

Either Party reserves the right to terminate this Agreement at any time, for any or no reason, subject to ninety (90) days prior written notice to the other party hereto. Any program or activity that has already commenced pursuant to specific cooperation agreements executed between the parties hereto, if executed, shall survive termination of this Agreement and be completed to the best of both parties' abilities pursuant and subject to the terms of the relevant specific cooperation agreement.

This Agreement is drafted in 2 original copies in English with identical content.
