

STUDENT EXCHANGE AGREEMENT

Between

OSH TECHNOLOGICAL UNIVERSITY, OSH, KYRGYZSTAN

And

Jeonju University

To promote the advancement of international understanding, academic excellence, dissemination of learning and strengthening cultural ties **OSH TECHNOLOGICAL UNIVERSITY-** and Jeonju University agree to the following terms and conditions in exchanging students.

1. The number of exchange students from each institution could be up to 5 students each year and the two institutions can decide the number of exchange students by mutual consent of each institution. This number may vary in any given year, provided a balance of exchanges is obtained over each academic year within the terms of the agreement.
2. The normal exchange period shall be one semester or one year without any restriction on their desired majors of study, in principle. The requests for extension require approval of both host and home institutions.
3. Each institution is responsible for selecting qualified candidates and recommending them to the host institution. The specified regulations for selection of exchange students will be set by the home institution. However, the final decision to accept or reject exchange students lies on the host institution.
4. Credits obtained by the students under this agreement can be accepted as degree credits at their home institution so far as its academic regulations permit.

5. The exchange students will be required to pay tuition fees at their home institution and do not have to pay the tuition and entrance fees to the host institution.
6. The host institution will make an effort to assist exchange students to obtain dormitory accommodation, and the dormitory fees are required to be paid by the exchange students.
7. The exchange students should pay for all personal expenses incurred at the host institution, including visa, travel, meals, and health insurance.
8. This agreement is made in English with a copy for both institutions.

This agreement shall be effective on and after the date of signing by the authorized representatives of the two universities, and shall remain in force until either party wishes to terminate. Either institution may amend this agreement by mutual consent at any time. In order to terminate, a written notice must be issued at least one year earlier.

INTERNATIONAL MEMORANDUM OF UNDERSTANDING AND AGREEMENT

BETWEEN

OSH TECHNOLOGICAL UNIVERSITY, OSH, KYRGYZSTAN

AND

JEONJU UNIVERSITY
SOUTH KOREA

This international memorandum of understanding and agreement is established to realize the mutual benefits of educational exchange between OSH TECHNOLOGICAL University and Jeonju University. This memorandum remains in force for five (5) years from the date of signature and may be modified through mutual consent.


Activities envisioned under this memorandum include:

- Exchange of faculty members and students, and internship placement
- Conducting joint professional training
- Sponsoring cooperative seminars, workshops and other academic meetings on matters of mutual interest with understanding that financial arrangements will be made on an ad hoc basis
- Promotion of collaborative research
- Other activities within the scope and mission of both institutions

In order to carry out the above-mentioned activities, a detailed plan must be agreed by upon consultation between the two institutions. It is implicit that each and every activity undertaken under this agreement is approved by the appropriate officials at each institution and must fall within each institution's academic and fiscal constraints.

Host institution policies govern the scope of activities of exchange participants while abroad. The sending institution will ensure adequate health, accident, and repatriation insurance coverage as a condition of participation.

This agreement may be modified at any time after due consultation between the two institutions.
